In 2011, the Bahamas Chamber of Commerce and The Bahamas Employers' Confederation amalgamated to form The Bahamas Chamber of Commerce and Employers' Confederation (BCCEC). Today the BCCEC is a Non-Government, Not-for-Profit, Business Member Organization that represents the interest of the private business sector and employers in The Bahamas. The amalgamation of the two entities has enabled the BCCEC to more effectively advocate for national policies that drive the socioeconomic climate of The Bahamas while encouraging the development of the business environment in the country.

The BCCEC works to stimulate and sustain the country's economic growth by providing a platform where members can engage in constructive dialog with the policymakers and the community activist to build a strong, sustainable, healthy, and robust economy. Though the islands that form our archipelago are unique, they encounter both common and island-specific challenges.
